Based on the order of the Hon'ble High Court, the Government of Telangana (Higher Education (TE/A2) Department) vide G.O. Ms. No. 2 dated 25.01.2017 has refixed the tuition fee of Rs. 66,000/- per annum for the academic years 2013-14, 2014-15 and 2015-16 (Rs. 66,000 – Rs. 61,200 = Rs. 4,800/-), thus there is an increase of Rs. 4,800/- per annum.

Therefore, all the B.Tech students of batches 2013-14, 2014-15 and 2015-16 are hereby informed to pay the difference of tuition fee amount on or before <u>February 28, 2017</u>.

The details of the Tuition fee amount payable is as follows:

B. Tech IV Year (Batch 2013-14) – Rs. 4800 X 4 (for the academic years 2013-14, 2014-15, 2015-16 & 2016-17) = Rs. 19,200/-B. Tech III Year (Batch 2014-15) – Rs. 4800 X 3 (for the academic years 2014-15, 2015-16 & 2016-17) = Rs. 14,400/-B. Tech II Year (Batch 2015-16) – Rs. 4800 X 2 (for the academic years 2015-16 & 2016-17) = Rs. 9,600/-

ORDER:

Government have notified the fee structure for Under Graduate Engineering Courses in Private Un-aided Institutions in the State for the Academic Years 2013-14, 2014-15 and 2015-16 including CVR College of Engineering, Ibrahimpatnam, Ranga Reddy District, for the Block Period of 2013-14 to 2015-16 at Sl. No.170 for an amount of Rs.61,200/- in Annexure -II vide reference 4th read above.

- 2. Aggrieved by this, the CVR College of Engineering, Ibrahimpatnam, Ranga Reddy District has challenged the above orders and approached the Hon'ble High Court by way of filing WP No. 19726 of 2013. The Hon'ble High Court has passed common interim order dt.26.04.2014 directing the 1st Respondent i.e. APAFRC as follows:-
 - " I direct the AFRC (1st Respondent) to provide a brief hearing of not exceeding two hours duration to those colleges who make a request to provide such a specific and brief hearing of not exceeding two hours duration of those colleges who make a request to provide such a specific and brief hearing to satisfy the AFRC that the daims, which have not been found favor by the AFRC are legitimate and can be explained to the satisfaction of the AFRC. Therefore all such colleges/writ petitioners are provided one week time from today to inform the AFRC either online or through communication sent by registered post that they are desirous of seeking a brief hearing. Upon receipt of such information, a schedule of hearing may be drawn and communicate it online and also by post to the respective college..."
- 3. Accordingly, the AFRC vide letter dt.25.08.2014, has sent the revised proposals to the Government, in respect of CVR College of Engineering, Ibrahimpatnam, Ranga Reddy District for revision of fee structure, which remained the same fee as fixed vide reference 4th read above i.e. Rs.61,200/-
- 4. Again, the CVR College of Engineering has filed WP No.38046 of 2014 in the Hon'ble High Court, with the following prayer:

"The Hon'ble Court may be pleased to permit the 2nd Petitioner i.e. CVR College of Engineering to collect a fee of Rs.81,800/- per student for the Block Period 2013-14 to 2015-16."

- 5. The Hon'ble High Court in its order dt.10.03.2016 in WP No 38046 of 2014 filed by Cherabuddi Education Society, CVR College of Engineering has issued the following direction:
 - "89. For the aforesaid reasons, the Writ Petition is allowed, and the orders impugned dated 12.09.2014, issued by the AFRC/First Respondent herein vide proceedings No.1/AFRC/FF/-UG-ENGG/2013-16(35) and Lr. No.1/AFRC/FF0/2013-14/173, dt.25.08.2014, are hereby set aside and the matter is remanded to the first respondent for fresh consideration and for passing the orders afresh after giving notice and opportunity of being heard to the petitioners. Petitioners herein are also entitled to furnish additional information, if any. This entire exercise shall be completed within a period of one month from the date of receipt of this order."
- 6. Accordingly, the TAFRC vide reference 9th cited has sent the revised proposal to the Government with the revised Fee for an amount of Rs.66,000/- for the Under Graduate Engineering Courses in the CVR College of Engineering, Ibrahimpatnam, Ranga Reddy District for the Block Period from 2013-14 to 2015-16.
- 7. Government after careful examination of the entire metter, hereby issue the following Notification to Re-fix the Fee in respect of CVR College of Engineering, Ibrahimpatnam, Ranga Reddy District for the Block Period from 2013-14 to 2015-16 for Under Graduate Engineering Courses as mentioned below, which shall be published in the Telangana Gazette.

NOTIFICATION

In exercise of the powers conferred under Rule 9 of the Telangana State Unaided Non-Minority/ Minority Professional Institutions (Regulation of Admissions into Under -Graduate and Pharm-D (Doctor of Pharmacy), Professional Courses through Common Entrance Test)Rules, 2011 issued in the G.Os 2rd and 3rd read above as adapted for the Telangana State vide G.O. 5th read above, read with subrule (V) of Rule 4 of the Telangana Admission and Fee Regulatory Committee (For Professional Courses offered in Private Un-Aided Professional Institutions) Rules, 2006, issued in the G.O. 1st read above as adapted for the Telangana State vide G.O. 6th read above and in pursuance of the recommendations of the Committee (TAFRC) in their Meeting held on 09.12.2016 and in compliance of the orders of Hon'ble High Court dt.10.03.2016 in WP No 38046 of 2014, the Governor of Telangana hereby notifies the revised Fee for Under Graduate Engineering Courses in the CVR College of Engineering, Ibrahimpatnam, Ranga Reddy District for the Block Period from 2013-14 to 2015-16:-
